Membership Confirmation: All memberships are non-transferable. All refunds will be subject to a \$35.00 administration fee plus HST. A full refund will be granted within 7 days of purchasing a membership with an e-mailed request and an administration fee will not apply. All other refunds are less a prorated amount for the number of days the membership was active. Memberships are active from the date of purchase. They become non-active at the end of the season or upon our receipt of your application for refund. Any refund will take approximately 2 – 4 weeks.

Non-use will not be considered a reason for a refund of membership. Refunds will only be considered for medical reasons with proper medical documentation.

CCA fees for all entries and scratch fees are the responsibility of each paddler. Fees must be paid to the Club Treasurer prior to CCA. Each paddler is required to bring and wear his/her life jacket at all times unless otherwise specified by coaching staff.
